MN Pump worked on #1 pump and #2 lift station, needed new seal trying to repair but may need a new one seal burnt, no oil, water in the reservoir. South pumps have been rebuilt/repaired, North pumps has only had maintenance and approximately 15 years old. Seals to be changed every 5 years or so. Empire Pipe cleaned out. Discharge last month, tested good, last discharge last week.
- b. Water is good, 21,000 gallons a day.

5. Road/Bridge:

- a. Gary Braaten gave report of 31st St, always rough and has a lot of traffic; otherwise roads are good for winter.
- b. Snowplowing hard to turn around with grader in Turtle Creek Estates in cul de sac (Austin Township). Gary Braaten made the motion to send a letter to Austin Township, effective February 1, 2018, we can no longer snowplow Austin Township roads, Steve Persinger seconded. Motion passed.

6. Election:

a. Clerk Allas has published and posted Filing of Notice for Supervisor candidates for Braaten, Vermilyea, and Persinger (formerly Penkava) positions.
