## 1. General Business:

- c. Dust Control: Freeborn Coop Oil \$.83/gallon, Ken Penkava made a motion to accept the bid from Freeborn Coop Oil, Lynn Allas seconded. Motion passed.
- d. Mow Ditches: Lowell Franzen \$2,800.00/year, Ken Penkava made a motion to accept the bid from Lowell Franzen, Gary Braaten seconded. Motion passed.
- e. Rock:
  - i. (East side of Hwy 218) Swenson 1" \$8.00/ton with trucking \$5.95/ton, (West side of Hwy 218) Falk 3/" \$7.42/ton with RDS trucking \$7.20/ton, Gary Braaten made a motion to accept the bid from Swenson, Ken Penkava seconded. Motion passed.
  - ii. (only in Lansing) Bixby, gravel \$9.65/yd with RDS trucking \$6.00/yd, Ken Penkava made a motion to accept the bid, Duane seconded. Motion passed.
- 3. St. Michael's Addition Wastewater: Sheila Craig explained the responses from residents (10 replies from 21) 4 want to go with Austin, 1 stay in Lansing Township with new system, 5 remain in Lansing Township with their own system. Resolution #041917 Be it resolved that Lansing Town Board discontinue any further financial involvement to address the sanitary sewer issues.....5 Yea 0 Nay.

- 7. Road/Bridge: Road Committee inspection of gravel and culverts that need attention. Bernie is blading and discing the roads. Frost boils were better than past years. South of Dwight Ault is bad. Clerk Kris Allas to invoice Austin Township for 3 ½ hours @ \$100.00.
