July 16, 2024

Chairperson Duane Mortensen called the meeting to order at 6:07 pm. The Pledge of Allegiance was recited.

Schwartz has a new culvert and an old culvert (212 feet on Township ditch before it goes into the land), and Mark Ratigan cleaned & put in tile for 243rd St ditch.
