Ponds Hayground: Gary Braaten amended his motion for the bid acceptance to Mary Stoffey, for 3 year contract of \$307.00 each year, Steve Torgerson seconded. Motion passed.

Sewer/Water: Bernie Boverhuis gave report on Water – pumps good, weekly samples okay. Results all good at point of beginning, 650,000 gallons. Wastewater – transferred ponds, samples taken are good, lift station #2 – flow meter is good, 23,000/day. Lift station #1 – alarm alert, plugged with rags, etc. will have Empire Pipe vac debris out.

Road/Bridge: Gary Braaten gave report, return \$15,000 for DNR Road behind Jondals and will talk to Mike Hansen. SKB put rock on road, will put in new culvert after dirt from Rochester job is completed. Road inspection: 10 loads per mile for some spots – may be up to 93 loads. Need to clean ditches: 20<sup>th</sup> Ave NW D. Bergstrom – clean it. 43<sup>rd</sup> St NW, 12<sup>th</sup> Ave West of 31<sup>st</sup> St, water can't get to intersection. Signs were put up, Bernie Boverhuis marked signs for Village. Catch basins are crusted over, land owners responsibility to clean it. Bernie Boverhuis obtained cutting edges, Lansing Village roads were not graded as of yet.
