Zoning Report: Notice of permit for storage shed: Byers. Airport zoning meeting 8/24 – Bill Stegemann will watch by zoom.

Subordinate Service District Report: Wastewater: all pumps and controls working properly at this time, with no problems to report. No sampling required this month. Average daily flow to ponds for July was 21,000 gallons/day. Water: all pumps and controls working properly at this time, with no problems to report this month. No samples required to be sent to lab this month. Total water pumped for July was 357,500 gallons.

Road Committee Report: Supervisor Gary Braaten presented the report, rock is on, rained on, and graded. New cylinders on 2 injection lines were replaced. Checking into a grinder for ditches, to rent? Supervisor Gary Braaten made the motion to hire renting a grinder for the ditches, Supervisor Mark Ratigan seconded. Motion passed.
