Lynn Allas made the motion to approve the Agenda with addition of Recycling, Steve Torgerson seconded. Motion passed.

Water Sewer report by Bernie Boverhuis. Water is good, samples were good, total water pumped 685,000 gallons for May. Fox Electric quote \$1,950.00, instrument controls \$1,000.00 would tie in programming. Lynn Allas made the motion to accept quote from Fox Electric for \$1,950.00, Mark Ratigan seconded, Chairman Mortenson will sign and send to Brian at Fox Electric. Wastewater controls and pumps are good, May discharge twice, 5/16/19 pump calibration – to clean out, grease with degreaser, into lift station. 24,000 average daily flow.

Road Report: 90% of rock on roads, dust control Gary Braaten is thinking the week after July 4th with ½ rate of chloride. Steve Torgerson made the motion to apply at ½ rate chloride this year, Mark Ratigan seconded. Motion passed.

Worlein Property: Mark Ratigan made the motion to hold the Public Hearing on Cartway (520th from South 27) July 25, 2019 at 5:00 p.m. at the site, and continue Public Hearing at the Town Hall after; Clerk Allas to post and publish Notice of Hearing from Attorney Gilchrist, Lynn Allas seconded. Motion passed.
