## November 20, 2019

Attorney Troy Gilchrist explained the Encroachment Policy – ROW before the board. Gary Braaten made the motion to approve Resolution #112019A, Mark Ratigan seconded. Motion passed.

Attorney Troy Gilchrist explained the Vacation of 266<sup>th</sup> St. Resolution #11202019B, Lynn Allas motioned to approve it, and Mark Ratigan seconded. Motion passed.

Treasurer Diana Witt presented the Resolution 2019-01 for delinquent water/sewer bills, Mark Ratigan made the motion to authorize it, Gary Braaten seconded. Motion passed.

Road Committee: Mark Ratigan reported that we are getting a V plow for the blade, more information at December meeting. SKB – Chad Wangen purchased a used blade on their payloader to clean the road. FEMA, Duane Mortensen and Bernie Boverhuis met regarding 255<sup>th</sup> blacktop.
